#### **Our mission is:**

Operation Round Up contributions will be used primarily in the local area for charitable, educational and community needs to help provide opportunities for long-range enhancement of the communities' quality of life.

### **Evaluation factors are:**

 Generally awarded to non-profit programs, projects and organizations that improve the quality of life in our local communities.

- Emphasize: public safety, health care, selfsufficiency, basic human needs, our cultural environment, community leadership and social issues for youth.
- Only one grant per year will be awarded to an organization.

## Funding restrictions are:

Contributions are generally not awarded to:

- lobbying
- political causes
- religious causes
- veteran organizations
- fraternal organizations
- fundraising dinners
- · raffles or events
- individuals
- capital fund campaigns
- scholarship programs
- general operating funds
- national fund drives
- advertising

If your program requires overheads/administrative costs to be written into your grant, Dunn Energy Cooperative requires an itemized print out detailing these costs, so if the board chooses, they can omit funding for those costs.

## FROM THE BOARD ROOM

# October 2021 Board Meeting Highlights





## **Monthly Reports:**

Operations reported that 103 new services have been installed this year. Brushing continues in the Lucas and Tainter areas. Two linemen attended a Line Clearance

workshop in October and crews continue to work on line upgrades and maintenance as well as new services and pole replacements. Due to nice weather and good contractors, almost all of our work plan projects are completed for the year.

The Member & Employee Engagement report contained an update on the pollinator habitat. It was also reported that the EV Experience event and EV charger ribbon cuttings were both well attended and had great traction on a few different social media platforms.

September financials showed that September kWh sales were about 1.85% greater than budget. Since the Cooperative is having a good year a credit totalling \$150,000 was issued on September energy bills. The Board also reviewed a 10-year financial forecast.

The CEO/General Manager shared that there is progress being made in creating a new EV program, including charger sales, rates, and possibly additional public chargers. He also discussed current legislation

in Wisconsin regarding third-party ownership of renewable energy systems and the challenges that would create.

- Capital credit estate payout for deceased members.
- Audit committee report of all checks, ACH payments, wire transfers, credit card statements, and investments accounts.
- The selection of the cooperative auditing firm for 2022-2024
- A PCA credit for October bills due in November
- 10-year financial forecast
- To move forward with a cost-of-service study in 2021-2022
- To move forward with roof and block repairs

Director Zwiefelhofer reported on Dairyland Power activities for the month.

Reviewed the remodel plans for the front office area
