

Electric Cooperatives Create CHARGE EV

Regional electric vehicle charging network will alleviate range anxiety, encourage EV adoption

Dec. 16, 2020 – A group of 29 electric co-ops has created a regional electric vehicle (EV) charging network across Wisconsin, Illinois, Iowa and Minnesota named CHARGE EV, LLC. The network includes over 30 Level 2 and Level 3 charging stations.

"Being a smaller cooperative, Dunn Energy jumped at the chance to collaborate with other Electric Cooperatives to form Charge EV. We look forward to working with them and ZEF Energy to develop a larger regional charging network and to promote electric vehicles to our members," said Jesse Singerhouse, Dunn Energy Cooperative CEO. "A project like this would be difficult for a smaller cooperative to do on their own, by working together we can help our members and non-members alike feel more comfortable purchasing an electric vehicle in our region."

The group of co-ops is planning for future growth in EVs, and wants to alleviate "range anxiety," which is the concern some people have about traveling in an EV without a place to charge their vehicle.

"Our goal is to provide EV owners peace of mind driving from Iowa to northern Wisconsin, or from Minnesota to Illinois, knowing there are co-op powered chargers along their route. That will give people confidence to consider an EV and encourage growth in the EV market," said Jeff Springer, Manager of Innovation and Efficient Electrification at Dairyland Power Cooperative (La Crosse, Wis.).







The CHARGE EV infrastructure is just the start as the group plans for additional investments in the EV market including member education on installing home chargers and encouraging members to test drive EVs.

January 2021 Board Meeting Highlights



Monthly Reports:

Operations reported year-end work is in progress including retirements of old lines, inventory, and planning for 2021. There were 134 new services installed

this year including 71 homes. Our brushing and pole change out crews will be working in the Downsville area in 2021.

The Member and Employee Engagement report discussed our recent social media posts and the positive comments that were received from the December power cost adjustment credit members received. Interviews will be conducted soon for the open office position. A new employee handbook and training guide is being developed.

December year end financials showed strong local and total margins for 2020. Power sales were down, but purchase power costs were lower than expected and the employees and board did a great job of holding costs down.

The CEO/General Manager discussed issues related to mailing bills. Mail deliveries have been delayed and with the way the holiday fell caused a delay. Staff will be looking for ways to improve this.

- Capital credit estate payout for deceased members.
- Audit committee report of all checks, ACH payments, wire transfers, credit card statements, and investments accounts.
- New agenda format for the Board meetings.
- Designation of the General Manager/CEO as the delegate for the 2021 NRECA virtual annual meeting.
- Selection of 2021-22 rate options from Dairyland Power.

Director Gasteyer attained his Credentialed Cooperative Director certification.
